5. Status update on Lake Hallie Agreement - Mike

Scott Nicastro had questions regarding section 4.2 of the LH agreement and the issue of accumulated investment funds if one party terminates the agreement. Investment funds are for nets, windscreens and court resurfacing. Either party (the Village of Lake Hallie or CVPC) must give a 365-day notice of termination and the CVPC will determine how the funds are used within the guidelines of the purpose of the funds. The purpose is to leave the park in good condition or return it back to its former use.

A question was raised regarding recreational immunity for open play at Lake Hallie once the club has insurance for club sponsored events. This should not affect recreational immunity, but we will get a legal opinion on this.
